

**CITY OF PHILLIPSBURG
CITY COUNCIL MEETING
APRIL 2, 2018**

The Phillipsburg City Council met in regular session on April 2, 2018, 6:00 P.M., at the Phillipsburg City Office, 945 Second Street.

- CALL TO ORDER** The meeting was called to order by Mayor Lance Munyon.
- ATTENDANCE** PRESENT: Council members Bret Miles; Lynette Voorhees; Michael Wisner.
- ABSENT: Council members Terry McConnell; Pete Rogers; Mike James.

- PLEDGE OF ALLIGIENCE** The Pledge of Allegiance to the United States was led by Mayor Munyon.
- NO QUORUM** Since no quorum was in attendance, no action could be taken during the meeting.
- PRESBYTERIAN CHURCH PARKING** Roger DeWitt and Ryan Cole provided information concerning the parking improvements proposed for the Presbyterian Church at the corner of 3rd & E Streets. Discussion was held concerning ADA compliance and the corner ramps. Phase 1 of the project will provide off street parking on the east side and phase 2 will be on the south side of the church. A building permit will be submitted. Discussion will be held at the April 16 meeting.

- APPROPRIATION ORD.** Appropriation Ordinance #1055-03-18B was reviewed.
- FINANCE** Miles will be scheduling a Finance Committee meeting.
- WORK PLANS** 2018 work plans will be approved at the April 16 meeting.
- WATER LEAKS** Driggs provided information concerning the number of water leaks in 2018 compared to earlier years.
- APPOINTMENTS** Mayor Munyon will be making the April appointments at the April 16 meeting.
- LAW COMMITTEE VIOIOUS DOGS TRAFFIC ISSUES** Mayor Munyon reported the Law Committee had met. The Mayor had met with the Sheriff concerning viscous dogs and trailer parking. For vicious dog issues the sheriff's office will be contacted directly. The City and the Sheriff's Office will work together. For traffic issues, the Sheriff's Office should be contacted directly. If the City receives a complaint, the owner will be contacted to notify them of the complaint.

ECONOMIC DEVELOPMENT ADVISORY Mayor Munyon reported on the Economic Development Advisory Committee meeting. A representative of the Encore Living will be added to the committee. The group will be doing 2 surveys. One survey will be concerning business retention and the other about housing.

PUBLIC WORKS Driggs provided information concerning the work being done by the public works department. A maintenance position will be advertised.

AIRPORT An airport open house will be held April 11 at 5:15 p.m. to show the newly remodeled terminal building.

AQUATIC CENTER Twenty-six lifeguards have been hired for the summer swim season.

WATER The lead & copper testing results were good. Lime disposal options are still being considered.

PLANNING The Planning Commission will meet on April 18.
