ORDINANCE NO. 1393

AN ORDINANCE AMENDING SECTION 3-103 OF ORDINANCE 1384 OF THE CITY OF PHILLIPBURG, KANSAS, WHICH PERTAINS TO CONSUMPTION ON PUBLIC PROPERTY WITHIN THE CITY OF PHILLIPSBURG, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF PHILLIPSBURG, KANSAS:

Section 1. That Section 3-103 of Ordinance 1384 of the City of Phillipsburg, Kansas, is hereby amended to read as follows:

3-103 CONSUMPTION ON PUBLIC PROPERTY. (a) No person shall drink or consume any alcoholic liquor or cereal malt beverage on city owned property.

(b) Alcoholic liquor and cereal malt beverage is prohibited at 520 S. 7<sup>th</sup> Street, formerly known as the Phillipsburg National Guard Armory property, except for the large meeting room therein.

(c) Alcoholic liquor or cereal malt beverage is prohibited at 425 F Street, commonly known as the Phillipsburg Community Building property, except for the internal premises therein.

(d) Cereal malt beverage, commonly known as 3.2 beer, may be consumed at the Phillipsburg ball fields and Phillipsburg City Park.


Any person violating any provision of such section shall be punished as provided in Section 1-116 of Ordinance 1384, commonly known as the Code of the City of Phillipsburg, Kansas, as amended.

Section 2. That Section 3-103 of Ordinance 1384 of the City of Phillipsburg, Kansas, as originally written and approved on November 18, 2013, is hereby repealed.

Section 3. This ordinance shall take effect and be in full force from and after its publication in the official newspaper of the City of Phillipsburg, Kansas.
